Introduction

- With changes to ID/A waivers, eligibility extended to children under 8 (*Individuals with a developmental disability with a high probability of resulting in an intellectual disability or autism are eligible from age 0 through 8*)
- A focus on children supports our commitment to integrating the LifeCourse Framework in all we do.



What is the **AUTISM INSURANCE ACT?**

In Pennsylvania, your child's autism-related services may be covered by private health insurance, Medical Assistance (MA) or the Children's Health Insurance Program (CHIP) under **Pennsylvania's Autism Insurance Act (ACT 62)**. ACT 62 is a statewide insurance mandate specific to services provided to children and adolescents with Autism Spectrum Disorder (ASD).

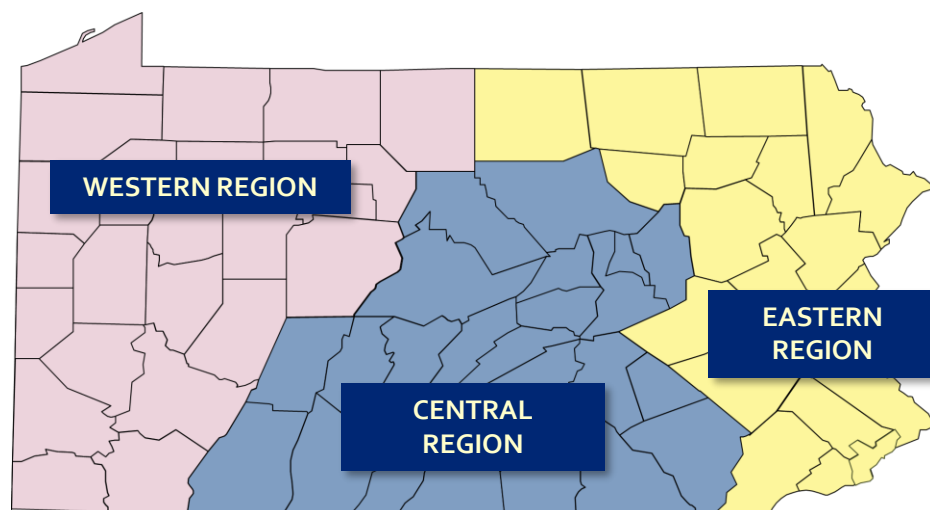


ASERT Resources for Families with Children

EARLY CHILDHOOD SCREENING AND DIAGNOSIS Autism Spectrum Disorder



How is autism diagnosed?

Diagnosing autism can be difficult as there is no specific medical test to make the diagnosis. Instead, autism is diagnosed by looking at an individual's behavior and development to determine if they are developing on target. Developmental screenings are used from birth to age 24 months to identify potential delays and refer for a comprehensive diagnostic evaluation. After 24 months, children are simply referred for a comprehensive diagnostic evaluation

What do I do if I suspect my child has autism?

- Monitor your child's development and keep track of any developmental delays or concerns
- Contact your child's doctor to discuss your concerns and request an autism screening

- ODP/ASERT Justice System Lead - Kate Hooven
 - ◆ Will conduct statewide training on issues specific to the juvenile justice system
- ODP is developing a strategic approach to training across the justice system
- ODP participates on the Mental Health Justice Advisory Committee, a cross systems workgroup, that looks at the challenge of youth interacting with the justice system
- ODP will be training the Trial Court Judges on ASD/ID at their annual training conference. This forum will allow us to reach over 200 judges.

- ODP is part of a cross-system effort to support the Family First initiative
- Family First Prevention Services Act has become law.
 - ◆ The biggest change to the structure of federal child welfare finance since the establishment of the Title IV-E entitlement in 1980.
- **Focus is on prevention**
 - ◆ States will now be able to use funds derived from Title IV-E of the Social Security Act – the entitlement that pays for child welfare – for “time-limited” services aimed at preventing the use of foster care in maltreatment cases.
 - ◆ Currently, IV-E is only allowable for spending on foster care placements and for assistance to adoptive families.

Training Efforts and Capacity Building to Support Children with AS/DID

- ◆ Building statewide capacity and competency in the professionals who assist and support Pennsylvanians with ASD across the lifespan, through consultation and technical assistance
- ◆ ODP/BSASP/ASERT virtual and face-to-face trainings
- ◆ Engagement with and technical assistance to counties
- ◆ Cross program office collaboration
- ◆ FBA (Functional Behavior Assessment) Training – Development of Online Training
