The current version of the map is Autism specific, directed to supporters. However, there are plans to make additional versions in the upcoming future.





 Provide outreach and communication to autism community about the expanded eligibility in ODP Program

ODP has continued outreach efforts to those individuals on the Adult Autism Waiver (AAW) list to encourage them to have their eligibility determined at their county/AE

- On July 1, 2022, letters were sent out to all individuals ages 18-22 on the current AAW list who have not yet had their eligibility determined.
- ODP continues to conduct individualized outreach to the individuals that are at the top of the AAW list in each region to ensure that their eligibility is determined so that when an AAW slot becomes available the enrollment process can begin immediately.

Strategy #7 (cont)



In January 2020, ODP began transitioning 2,228 individuals on the AAW interest list to ODP's waiting list, so that eligible individuals could be assessed for their urgency of need and prioritized accordingly for waiver enrollment.

- As of September 2022:
 - 537 of the 2,228 individuals are no longer on the AAW interest list due to their enrollment in a waiver, no longer being interested, or no longer meeting the eligibility requirements.
 - 445 of the 1,691 remaining individuals from the AAW interest list have completed their eligibility determination and are currently on the ODP waiting list.*
 - 1,246 of the 1,691 remaining individuals from the AAW list are pending transition to the ODP waiting list, upon completion of the process for determining eligibility.
