ISAC #14 Racial Equity



Communities are richer, more just, and stronger when we honor and respect the whole of racial diversity. Access to a quality, person-centered, culturally competent system of supports and funding must be equally available regardless of race. Services must include planning over a life span and address racial disparities, including disparate outcomes. The duty to ensure that racial diversity is promoted and supported, at all levels within the services system, must be embraced.

ISAC#14: Promote Racial Equity. Strategy #1

Consistently include breakdowns by race, in data analysis and reporting, to support identification of racial equity performance improvement opportunities and incorporation into quality management plans to drive improvement activities and use to measure progress on these activities.


PDS Analysis by Race



Individuals Enrolled in Consolidated, Community Living and P/FDS Waivers & PDS Participants (AE with over 1000 Enrolled)



DHS Strategic Plan and Goal Setting

DHS Strategic Plan

ODP has identified for reporting measures related to establishing an equity-based goal for the DHS Strategic Plan and Goal Setting document. They are:

- Access to the waitlist based on an overall population which can be tied to ODP's high level goal #1: End the waiting list for home and community-based services for adults with an intellectual disability and autism; and
- 2. Demographic information from the National Alliance for Direct Support Professionals which can be tied to ODP's high level goal #3: Improve workforce competency and retention.

Changing the Census Methodology

Changing how U.S. forms ask about race and ethnicity

- The current standards require federal forms that ask participants their identities to inquire about race and ethnicity through two separate questions. That's why on census forms, for example, before you see the race question, there a question about Hispanic or Latino identity, which the U.S. government considers to be an ethnicity that can be of any race.
- In the 2020 census, close to 44% of Latinos either did not answer the race question at all or checked off only the box for the mysterious catchall category "Some other race," <u>according to data</u> the Census Bureau released last month.

Changing The Census Methodology

- Combining these two topics into one question, while allowing people to check as many boxes as they want, is likely to reduce confusion and share of Latinos who mark "Some other race," <u>bureau research from 2015</u> suggests.
- There are concerns about how a combined question could affect racial data about Latinos.
- A combined question would allow some Latinos to answer the question by only checking a box for "Hispanic or Latino."
