
Projected Spending Across DHS



Foundations of Health

- Continuing ODP Multi-Year Growth Strategy
 - Last year Shapiro Administration began a multi-year strategy to expand access to home and community-based services and effectively end the emergency waiting list for adults with intellectual disabilities and autism.
 - In the last year:
 - Invested \$280M in new funding for rates, supporting increased wages cross this system
 - DSP Vacancy Rate now 14% lowest since 2015
 - Invested \$74.8M to begin process of eliminating adult emergency waiting list
 - Waiver capacity increased by 1,300 people since July 2024
 - 2025-26 Budget annualizes these investments to continue this progress





Multi-Year Program Growth Strategy Status

- Readiness reviews began January 1 with all AEs rolled in by 12/31/25.
- Allegheny county first to be approved to use new management approach.
- Since the Governor's Feb 2024 announcement ODP reduced the adult waiting list (age 21+) by 19% (3,703 adults remain on emergency list)
- Just since the Feb 2024 announcement, 8% increase in total program capacity meaning that finally more than 40,000 individuals with ID/A can access home and community-based services. Current program capacity is 41,555 waiver capacity.


