Objective

- **Technically, this strategy belongs to ISAC**
Recommendation #3 – Increase Employment:
- **Collect and publish data from prevocational service providers (in both licensed day habilitation and prevocational facilities) on rates of moving people to CIE.**

- **Approaching this from 2 angles:**
 - Survey to CPS Providers asking for self-reported data, i.e.:
 - # of individuals receiving pre-vocational CPS
 - # of those individuals who are receiving any employment service from the same provider
 - How the provider is connecting with businesses and other local community members
 - If the provider has a waiting list for CPS services
 - Pre-Survey Data Collection
 - CPS providers who are qualified to provide BC or SE
 - Of those providers, # enrolled w/ OVR to provide BC or SE
 - # of CPS Individuals receiving employment service
- **Both surveys are being finalized – updates in 2026 w/ Recommendation #3**

Activities Happening Across the Commonwealth

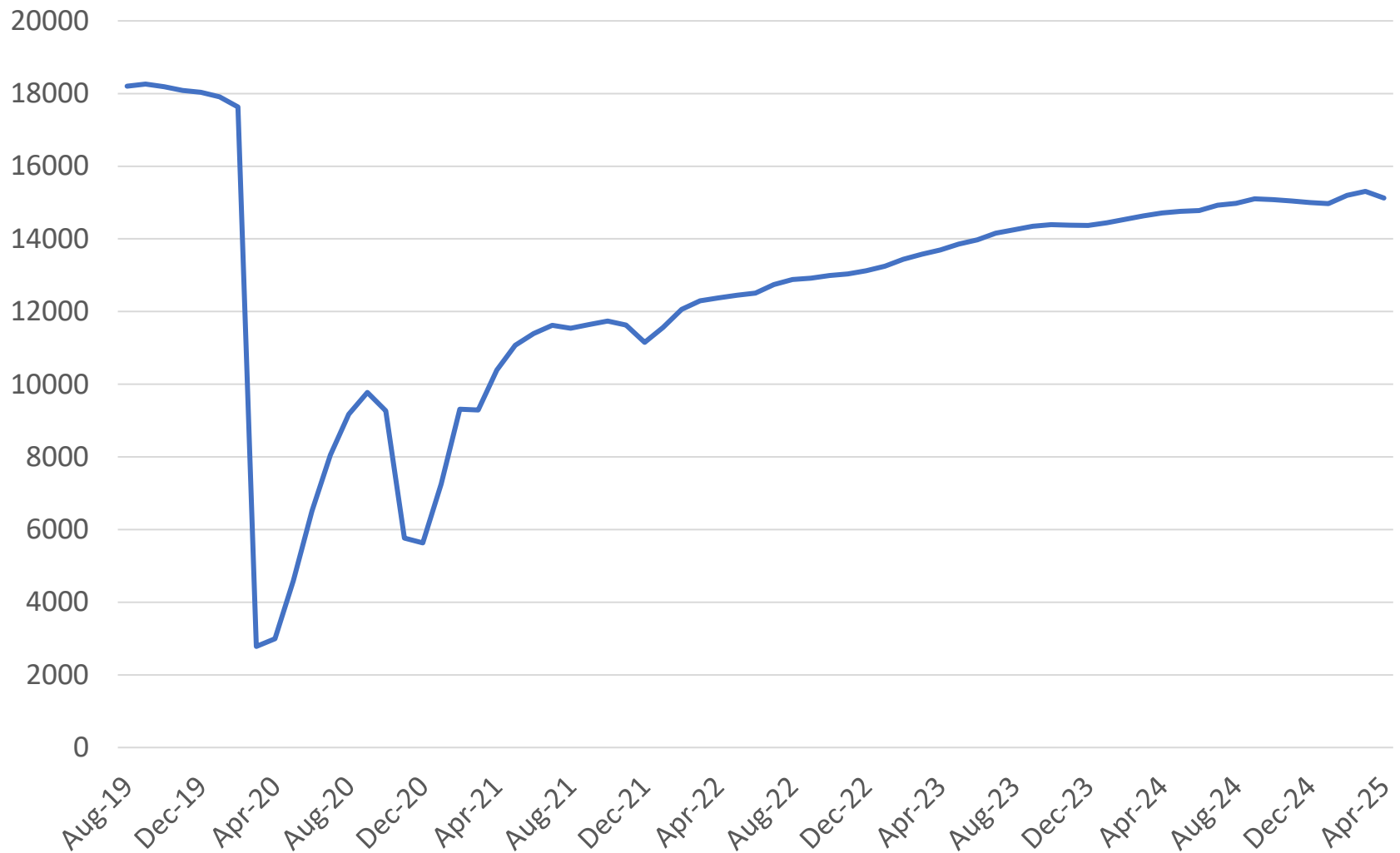
- **SCs discussing community inclusion with a focus on individual preferences such as where the individual wants to go and how often they want to go out.**
- **AEs reviewing and analyzing data and service documentation to identify providers that are meeting goals for CPS.**
- **Regional CPS Leads participating in forums for individuals and families to identify opportunities, challenges and innovative solutions to enhance community inclusion.**
- **CPS agencies are expanding their hours to accommodate interest and schedules of the individuals they currently serve.**
- **AEs working collaboratively with SCOs to utilize LifeCourse tools to improve SCs competence with supporting individuals with finding and participating in activities of their choice.**
 - One example is an AE with an outreach coordinator who attends transition meetings at schools to utilize the LifeCourse tools with the team



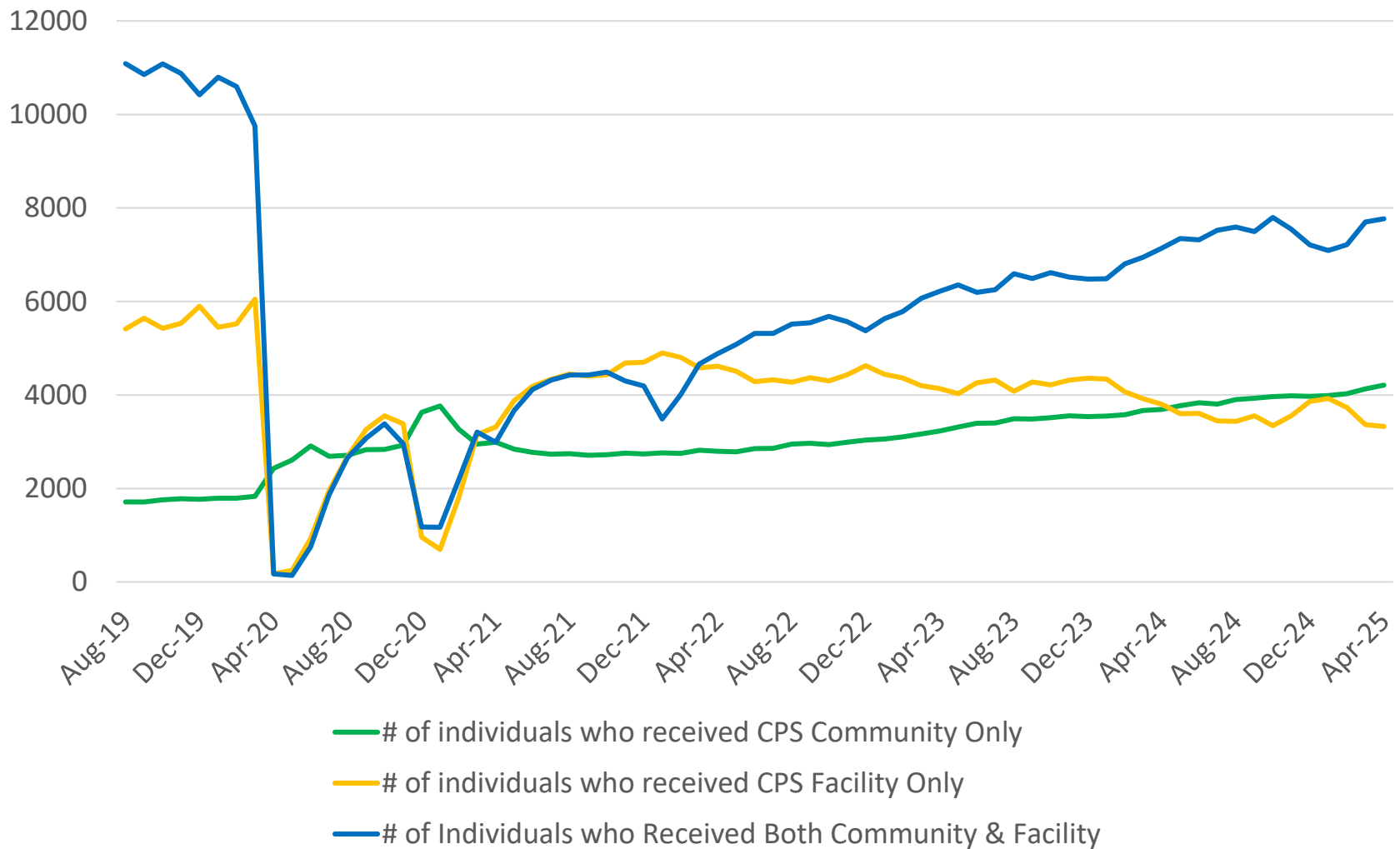

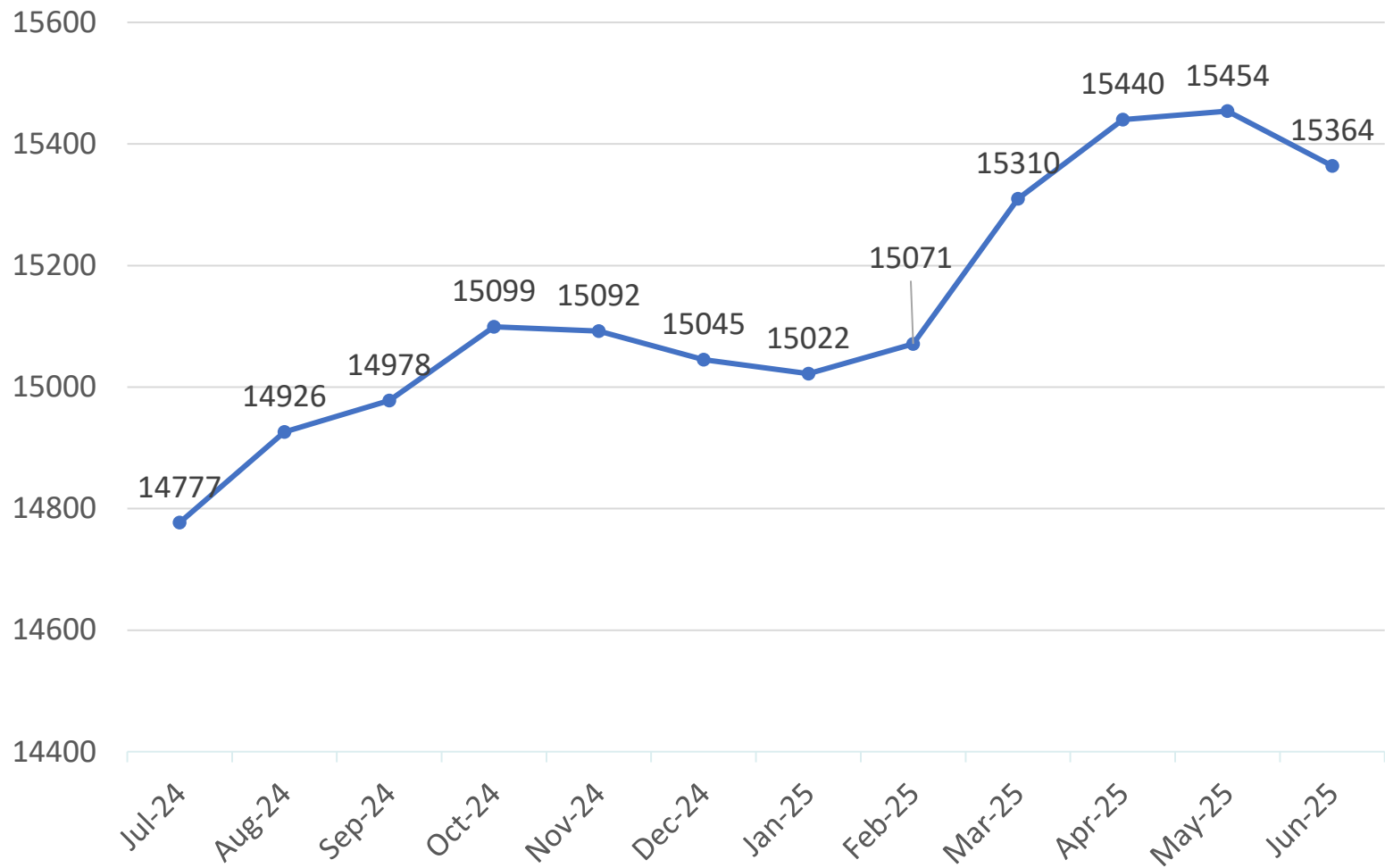
2019-2025 Total # of Monthly CPS Recipients



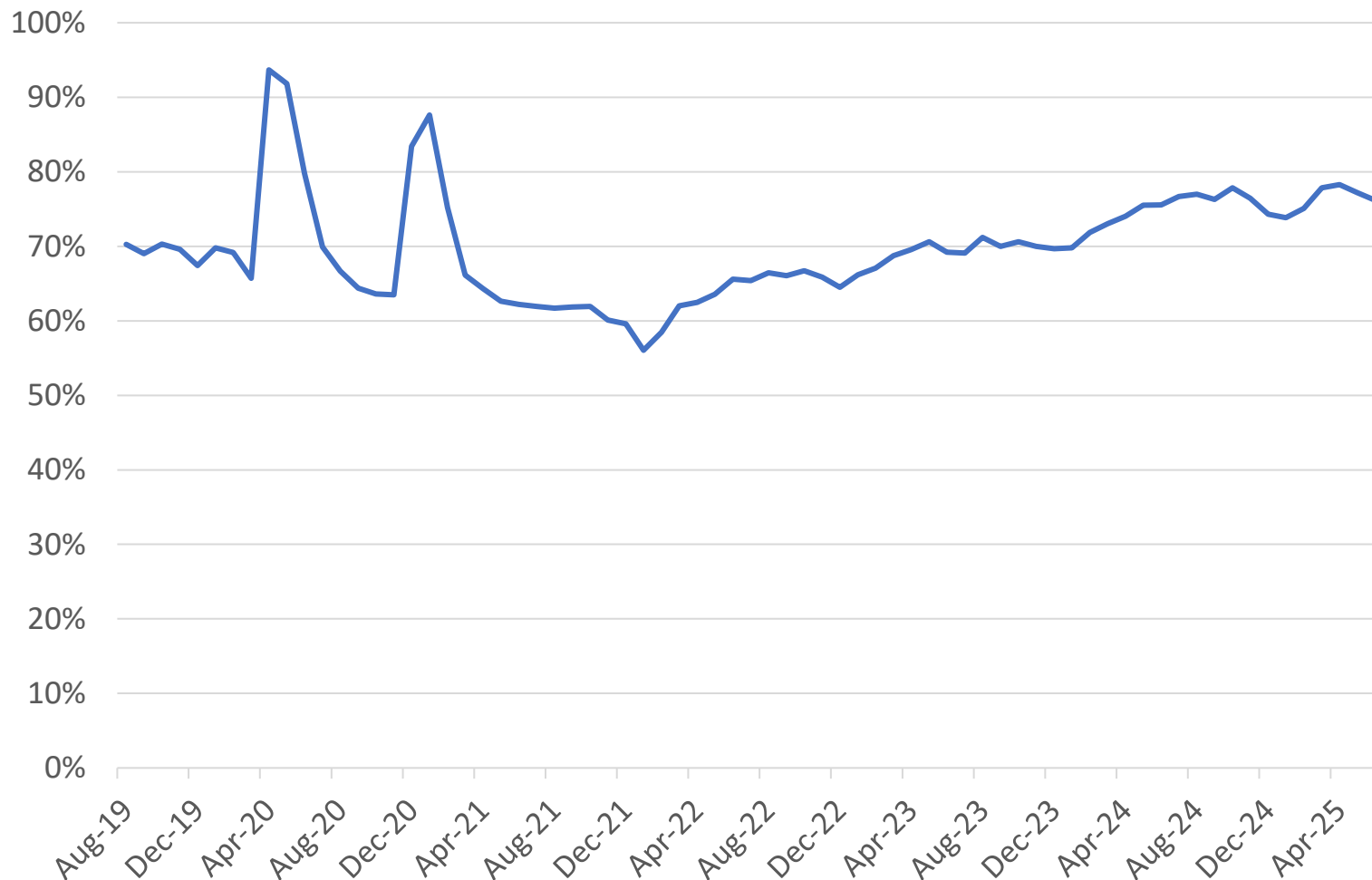
2019-2025 # of CPS Recipients by CPS Service



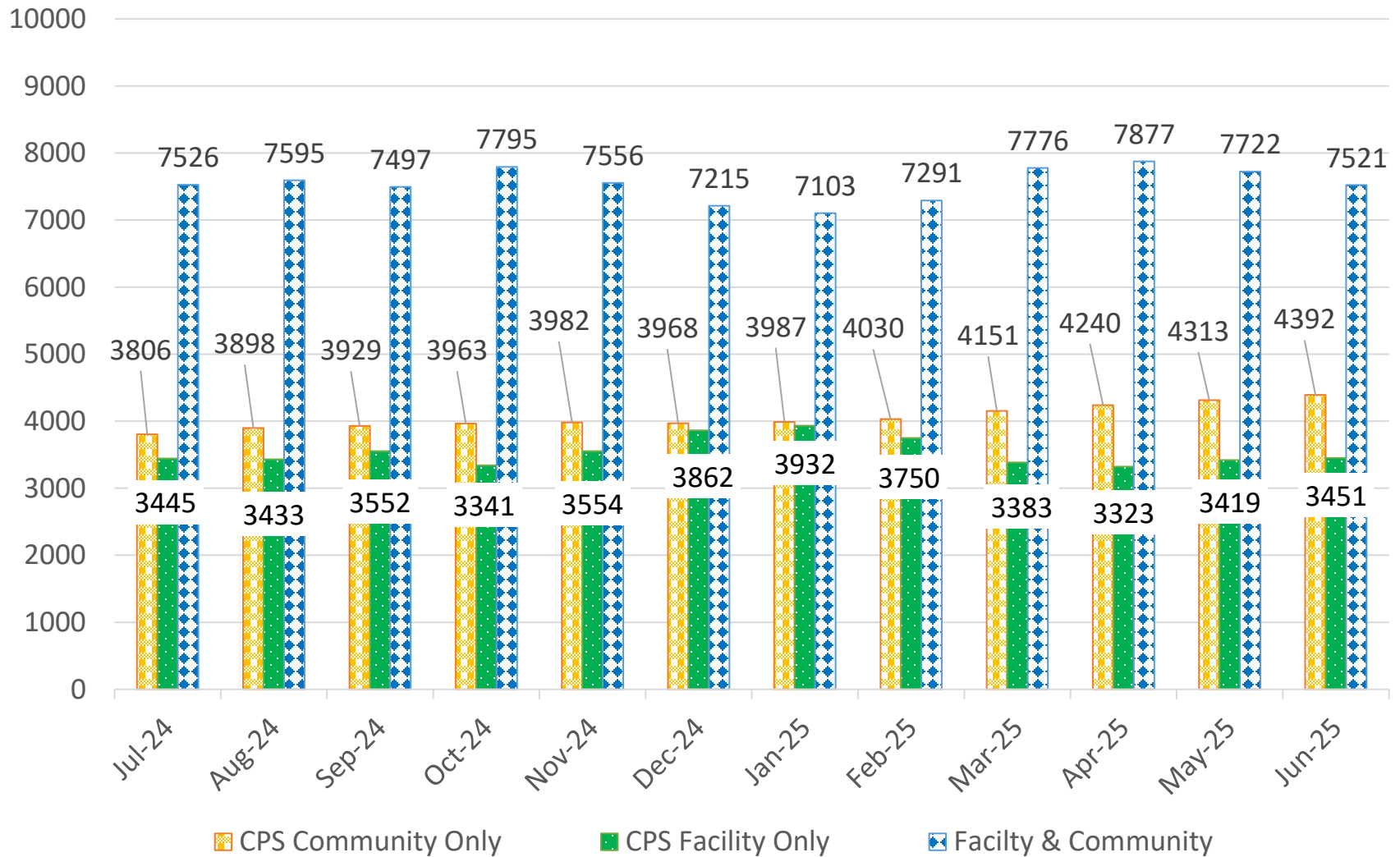
Total # of CPS Recipients in FY24-25



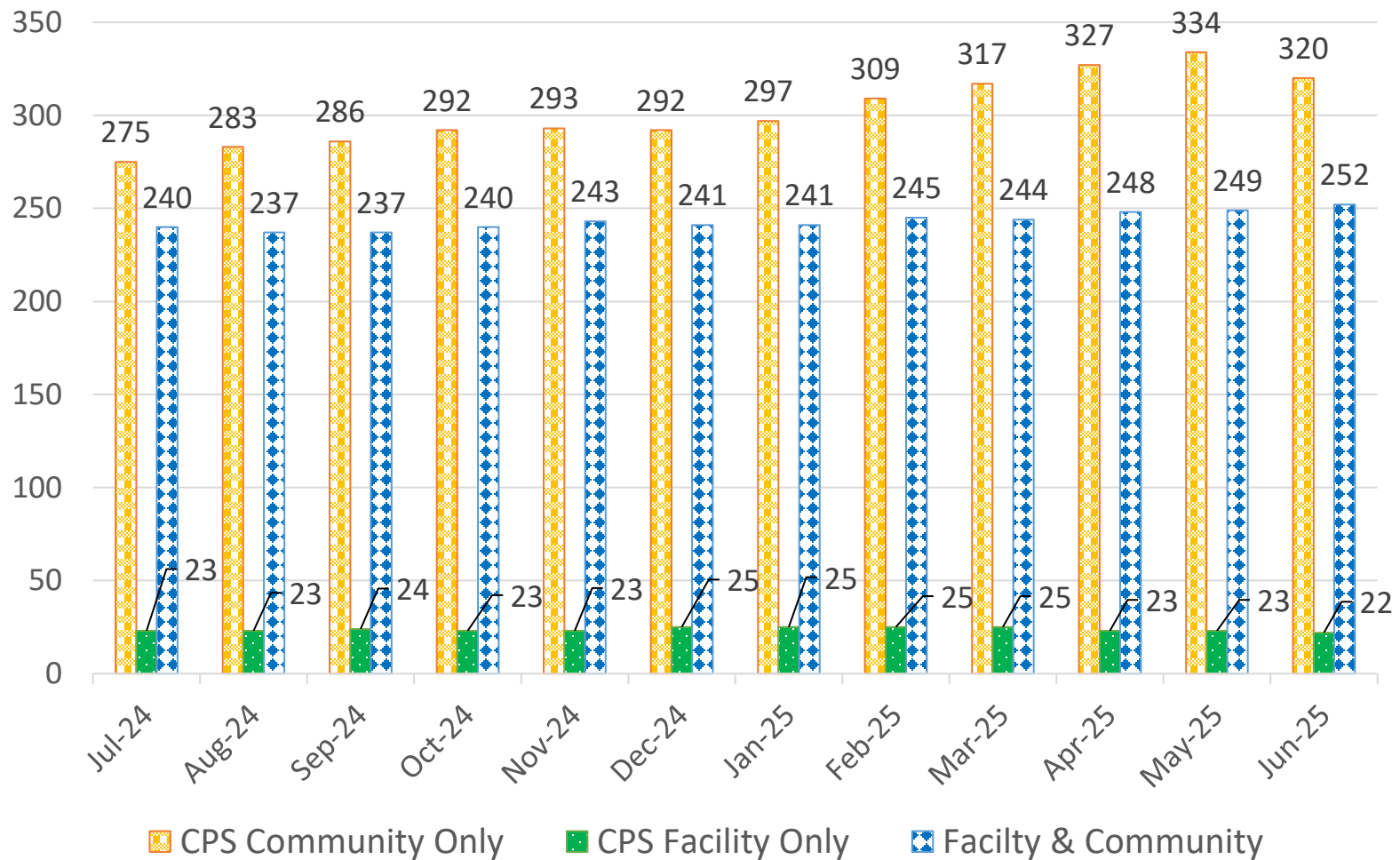
% of CPS Recipients who Received CPS Community
