Adult Autism Waiver (AAW) Updates

- AAW Renewal 7/1/2026
- Public comment anticipated January-February
- Interest list conversion to waiting list project near completion
 - Prior to Sept. 2024- 1,123 individuals on AAW interest list (no ICF level of care determination conducted)
 - Extensive outreach and eligibility determinations conducted
 - Anticipated AAW waiting list will be approximately 400 individuals (meet ICF level of care)

January 2026 ID/A HCBS Waiver Amendments

- **April 19 to May 26:** Public comment period for changes to the 1915(b)(4) waiver, Targeted Support Management State Plan, and Consolidated, Community Living, and Person/Family Directed Support (P/FDS) Waivers
- **May 27 to July 1:** ODP reviewed public comments and made changes based on public comments
- **July 31:** ODP submitted the 1915(b)(4) waiver and Consolidated, Community Living, and P/FDS Waivers to the Centers for Medicare and Medicaid Services (CMS) for review and approval
- **August 25:** ODP submitted the State Plan Amendment for Targeted Supports Management (still pending approval)
- **October 15:** CMS approved the 1915(b)(4) and waiver amendments effective January 1, 2026. No major changes made

Performance-Based Contracting Updates: Supports Coordination

- Received Performance evaluation and pay-for-performance data submission Oct 1- Nov 1, 2025
- Signed *Agreement for Provision of Supports Coordination Services* received for all SCOs

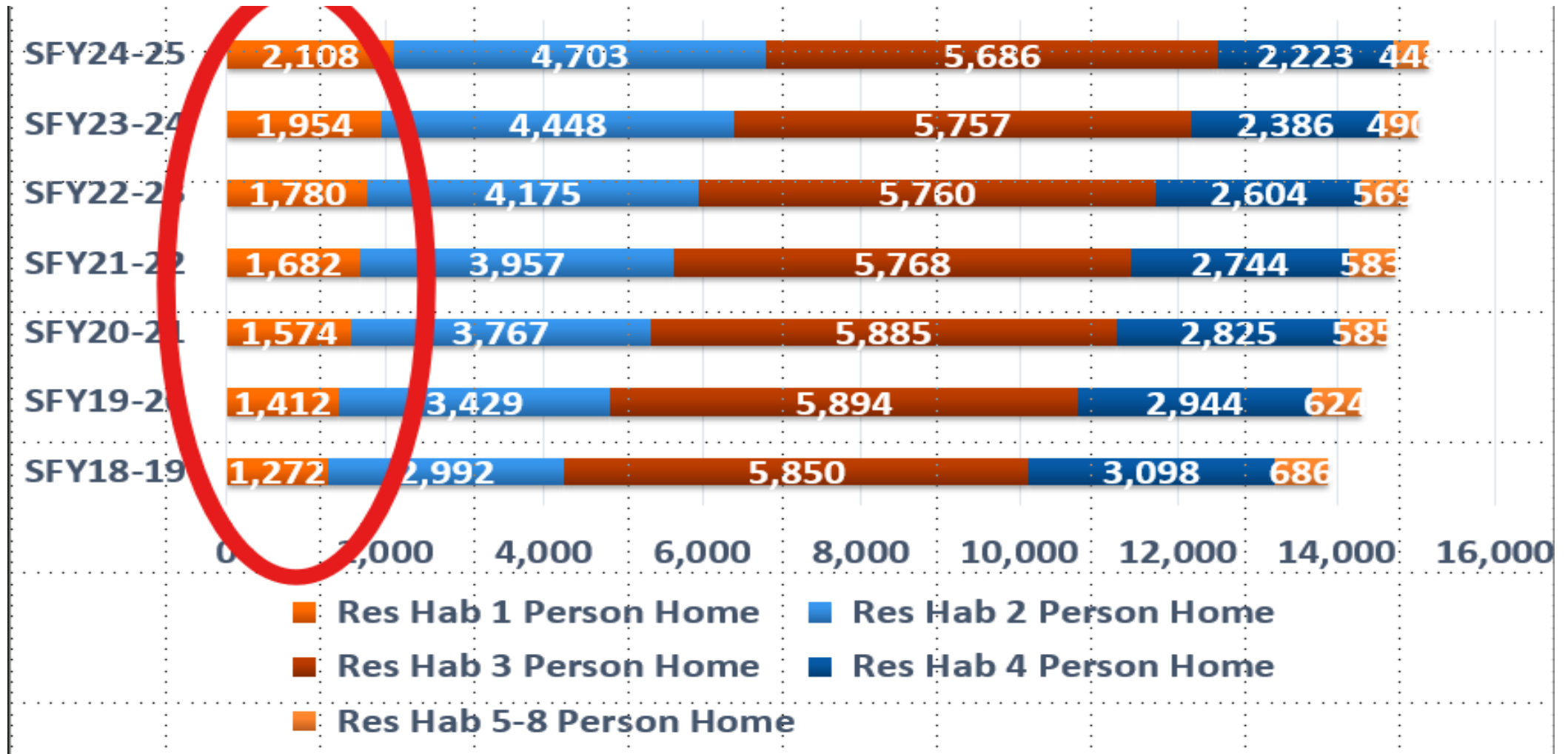

All FY Snapshot data pulled 6/30



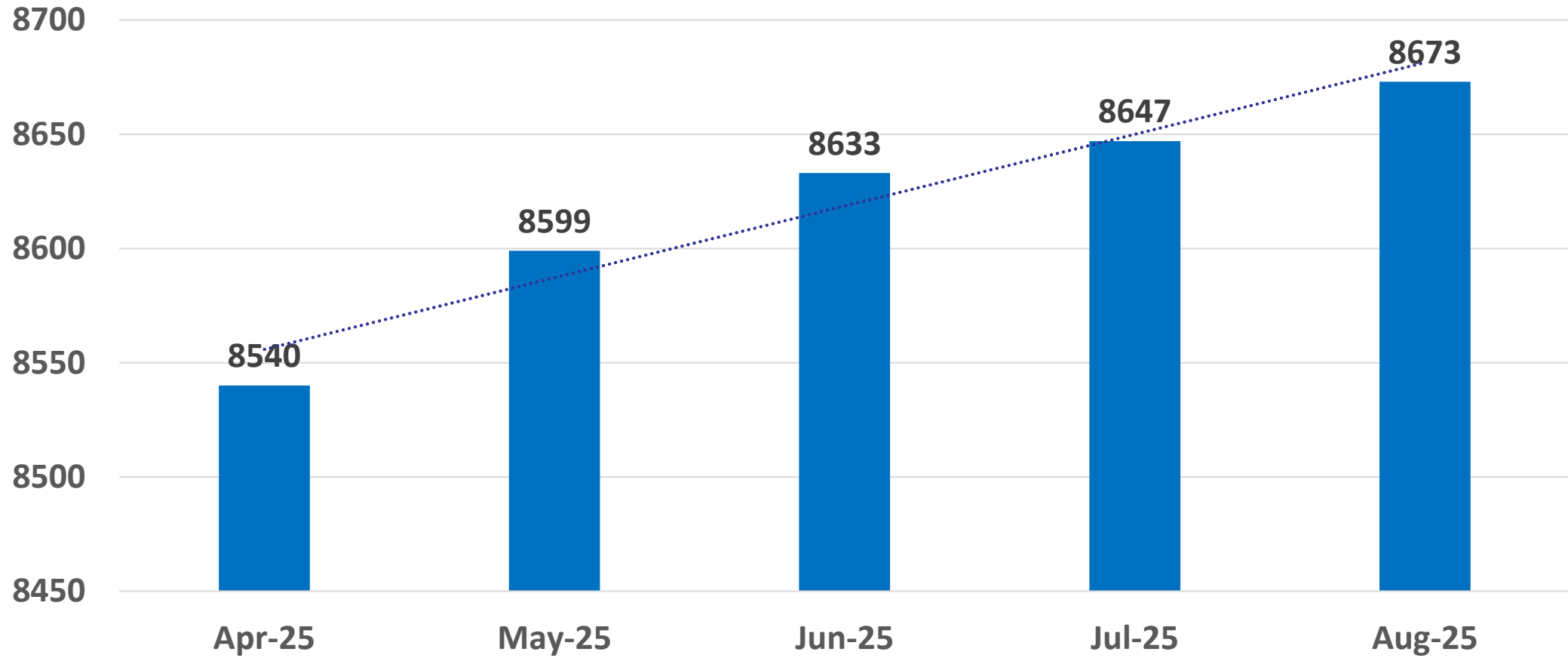
